

Terms of Use

These Terms of Use ("Terms") govern your relationship with the Leafrow mobile application (the "Service") operated by Leafrow ("us", "we", or "our").

Please read these Terms carefully before using the Service. Your access to and use of the Service is conditioned on your acceptance of and compliance with these Terms. If you do not agree with any part of the Terms, you may not use the Service.

Subscriptions

Some parts of the Service are offered on a subscription basis ("Subscriptions"). Subscriptions are billed in advance on a recurring and periodic basis ("Billing Cycle"). Billing cycles are set on a monthly basis, depending on the subscription plan selected at the time of purchase.

Payment will be charged to the user's Apple ID account at the confirmation of purchase. Subscriptions automatically renew unless auto-renewal is turned off at least 24 hours before the end of the current Billing Cycle.

The user's Apple ID account will be charged for renewal within 24 hours prior to the end of the current Billing Cycle, and the cost of renewal will be identified at that time.

Subscriptions may be managed by the user, and auto-renewal may be turned off by going to the user's Apple ID account settings after purchase. Any unused portion of a free trial period, if offered, will be forfeited when the user purchases a subscription.

Leafrow does not collect, process, or store users' payment information. All payments are handled securely by Apple in accordance with App Store policies.

Fee Changes

Leafrow reserves the right to modify subscription fees at any time. Any changes to subscription pricing will take effect at the end of the current Billing Cycle. Reasonable notice will be provided where required by applicable law.

Continued use of the Service after a fee change becomes effective constitutes acceptance of the updated pricing.

Refunds

Except when required by law, paid Subscription fees are non-refundable.

Content

The Service allows users to create, store, and manage content, including text and lists ("Content"). Users retain full ownership of their Content.

By using the Service, you grant Leafrow a limited, non-exclusive license to process and display Content solely for the purpose of operating and providing the Service. Leafrow does not sell or share user-generated Content with third parties.

You represent and warrant that you have the necessary rights to the Content you create and that such Content does not violate any applicable laws or third-party rights.

When AI features are used, user-entered text prompts may be transmitted to selected third-party AI providers (such as OpenAI, Google Gemini, YandexGPT) solely for the purpose of generating responses.

Accounts

You are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account. Leafrow is not responsible for unauthorized access resulting from your failure to safeguard your credentials.

Termination
